4. Attitude

Attitude is the X-factor.

New H-1B Rules (2025)

In September 2025, a major change was introduced:

- Employers must now pay a **USD 100,000 fee** when sponsoring *new* H-1B applicants from abroad.
- This does not apply to renewals or people already in the U.S. on H-1B.
- The change will make employers more selective, focusing on high-skill, high-salary roles.

If you're applying for H-1B, confirm that your employer is aware of this cost and willing to cover it.

Frequently Asked Questions

Q. How long is a tourist visa valid?

-Up to 10 years. Each entry usually allows a stay of up to 6 months.

Q. When does the Visa Integrity Fee start?

-January 2026.

Q. Can I drop off documents in cities without a VAC?

-Yes, at designated drop-off centers (fee ~₹1,200).

Q. What if my case goes into administrative processing?

-It can add weeks. Avoid non-refundable bookings until your passport is stamped.

Q. Can I skip the interview?
